ii)Headstones and Monuments: The design of headstones and monuments as well as the wording, including that which is proposed to be added to any existing headstone or monument, has to be submitted to the Churchwardens or other authorized member of the Chaplaincy Council for approval. In cases where a Faculty is required from the Diocese in Europe for alteration of an existing monument in the church, a fee is payable. Only headstones measuring a maximum of 80cms height are permitted. No other form of monument or perimeter walls are allowed.
